POLICY

To provide RV sites in the FMCA Campground with (1) full hook-ups, (50 amp electric, water, and sewer) or (2) electric only with water and dump station available to FMCA members on official FMCA business at the national office, and to provide RV sites for overnight parking to FMCA members not on official FMCA business on a space-available basis.

PROCEDURES

The following Campground Rules apply to usage of the FMCA Campground and will be included in the registration process.

CAMPGROUND RULES

Please observe these rules during your stay.

1. FMCA member “Goose Egg” emblem **must** be displayed on your RV.
2. Members on official FMCA business are limited to a maximum stay, free of charge, during their FMCA official business plus one day prior to and one day following completion of their business. Members at the campground for a called meeting shall have priority over the reservation system.
3. Members not on official FMCA business are limited to a maximum stay of two nights per month free of charge. Depending upon space availability, members may stay a maximum of five additional nights per month for a fee of \$20 per night. The Executive Director and/or President may authorize extended stays based upon a valid need and space availability.
4. FMCA members can make reservations online at FMCA.com or by calling 513-474-3622 or 800-543-3622. If you cancel your reservation, you will be charged a \$5.00 processing fee.
5. Members must check in and out of the campground online. A computer is available in the campground lobby for you to check in and out during normal business hours Monday through Friday 8:00 a.m. – 5:00 p.m. Check in time is 1:00 p.m. Check out time is by 11:00 a.m.
6. Overnight parking and/or reservations may be denied due to called meeting(s).
7. A dumpster is provided for disposal of trash. **NO** trash is to be left at the site.
8. Pets must remain on a leash at all times. Owners shall clean up after their pets.
9. Water faucet should be placed in the "down" position before leaving site.

10. If the backflow valve is found to be missing after your departure, you will be charged an additional \$10.
11. A telephone for emergency purposes is located at the rear of the building.
12. A chapter may schedule a two day rally, free of charge, at the Round Bottom Road facility once every two years; however, it must be limited to no more than eighteen (18) recreational vehicles. After the two free nights, the \$20-per-night fee will be charged per each rally participant. Following the rally, additional nights will depend on site availability. Rallies must be reserved by calling the national office ahead of time.
13. Campfires are not permitted.
14. Dog park is available to FMCA members only. Members using the dog park must abide by the rules as posted at the dog park.
